

2021 INDONESIA GOLF ASSOCIATON CHAMPIONSHIPS AND MATCHES

LOCAL RULES and TERMS OF COMPETITION

The following Local Rules and Terms of Competition, together with any additions or amendments as published by IGA at the golf course, will apply to all Championships and National Matches run by IGA.

For the full text of any Local Rule referenced below, please refer to the Official Guide to the Rules of Golf effective January 2019 and the Clarifications updated quarterly by The R&A, available at www.randa.org.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty (loss of hole in match play or two penalty strokes in stroke play).

I. Out of Bounds (Rule 18.2)

- Ia) A ball is out of bounds when it is beyond any wall defining a boundary.
- Ib) A ball that is played from one side of a road which is defined as out of bounds and comes to rest on the other side of that road is out of bounds. This is true even if the ball comes to rest on another part of the course that is in bounds for other holes.

2. Penalty Areas (Rule 17)

- 2a) When a penalty area adjoins a boundary, the penalty area edge extends to and coincides with the boundary.
- 2b) When a player's ball is found in or it is known or virtually certain to have come to rest in any penalty area where the ball last crossed the edge of the penalty area at a point that coincides with the boundary of the course, opposite side relief is available under Model

Local rule B-2.1.

Dropping Zones for Penalty Areas

Where a dropping zone is marked for a penalty area, it is an additional option for relief under penalty of one stroke. The dropping zone is a relief area. A ball must be dropped in and come to rest in the relief area.

3. Abnormal Course Conditions (including Immovable Obstructions) (Rule 16)

3a) Ground Under Repair

- (I) Any area bounded by a white line or a white dotted line, including spectator crossing points where marked.
- (2) Any area of damaged ground (e.g. caused by crowd or vehicle movement) that is considered by a referee to be abnormal.
- (3) Grass covered cable trenches.
- (4) French drains (stone-filled drainage ditches).
- (5) Seams of cut turf; Model Local Rule F-7 is in effect.
- (6) Yardage painted lines or dots on the putting green or in a part of the general area cut to fairway height or less are to be treated as ground under repair from which relief is available under Rule 16.1. Interference does not exist if yardage painted lines or dots only interfere with the player's stance.

3b) Immovable Obstructions

- (1) White lined areas and immovable obstruction they tie into are treated as a single abnormal course condition.
- (2) Landscaped garden areas and everything growing in them that are surrounded by an immovable obstruction are treated as a single abnormal course condition.
- (3) Mats that are secured and all ramps covering cables
- (4) Roads or paths surfaced with woodchip or mulch. Individual pieces of woodchip are loose impediments.

3c) Embedded Ball

Rule 16.3 is modified in this way: No free relief is allowed for a ball embedded in the stacked turf face above a bunker.

4. Immovable Obstructions Close to Putting Greens

Model Local Rule F-5 is in effect but is modified in this way: For a ball in the general area, relief is allowed only when both the ball and

the immovable obstruction lie in an area cut to fairway height or less..

5. Limiting When Stroke Made from Putting Green Must be Replayed

Model Local Rule D-7 is in effect and modifies Exception 2 to Rule 11.1b.

6. Ball Played From Outside Relief Area When Taking Back-On-The Line-Relief

Model Local Rule E-12 is in effect.

7. Integral Objects

The following are integral objects from which free relief is not allowed:

- 7a) Bunker liners in their intended position
- 7b) Wires, cables, wrappings or other objects where they are closely attached to trees or other permanent objects.
- 7c) Artificial retaining walls and pilings when located in penalty areas.

8. Temporary Power Lines or Cables

Model Local Rule F-22 is in effect and is modified as follows: mats that are secured and all ramps covering cables are immovable obstructions.

9. Temporary Immovable Obstructions

Model Local Rule F-23, with any additions or amendments in the additional Local Rule published by IGA, is in effect.

Replacement of Club that is Broken or Significantly Damaged

Model Local Rule G-9 is in effect.

II. Clubs and Balls

11a) List of Conforming Driver Heads: Model Local Rule G-1 is in effect.

Penalty for making a stroke with a club in breach of Local Rule: Disqualification.

11b) Groove and Punch Mark Specifications: Model Local Rule

G-2 is in effect.

Penalty for making a stroke with a club in breach of Local Rule: Disqualification.

11c) List of Conforming Golf Balls: Model Local Rule G-3 is in effect. Penalty for breach of the Local Rule: Disqualification. Note: An updated List of Conforming Clubs and Balls is available on www.randa.org.

12. Pace of Play (Rule 5.6)

Every Championship or Match has a Pace of Play Policy that will be strictly enforced. Please ensure you obtain a copy of the Pace of Play Policy and read it carefully before playing.

13. Suspension of Play (Rule 5.7)

The following signals will be used to suspend and resume play: Immediate stop for imminent danger – one prolonged note of a siren

Stop for a non-dangerous situation – three consecutive notes of a siren $% \left(1\right) =\left(1\right) \left(1\right) \left($

Resumption of play – two consecutive notes of a siren **Note**: When play is stopped for imminent danger, all practise areas will be immediately closed.

14. Practise (Rule 5.2)

- 14a) In stroke play, Rule 5.2b is modified in this way: A player must not practise on the competition course before or between rounds.
- 14b) In match play, Rule 5.2a is modified in this way: A player must not practise on the competition course before or between rounds.
 Exception: All recognised practise areas within the bounds of the course may be used by players for practise on any day of the competition.

15. Transportation

During a round, a player or caddie must not ride any form of motorized transportation except as authorized or later approved by the Committee. A player who will play, or has played, under penalty of stroke and distance is always authorized to ride on motorized transportation. The player gets the general penalty for each hole during which there is a breach. A breach between two holes applies

to the next hole.

16. Advise in Team Competitions (Rule 24)

Each team may name one advice giver who players in the team may ask for advice and receive advice from during the round. The team must identify each advice giver to the Committee before any player on the team begins his or her round.

17. Eligibility

Players must meet the eligibility provision established in the relevant Terms of Competition for the specific Championship or Match.

18. Anti-Doping

Players are required to comply with and be bound by any Anti-Doping Policy that is established for the Championship or Match in which they are playing, as detailed in the relevant Terms of Competition, as advised by prior notice or at the golf course.

19. Returning of Score Card

A player's scorecard is officially returned to the Committee when the player has left the recording office/area with both feet.

20. Deciding Ties

The method for deciding ties is provided on the relevant entry form or is published at the golf course by IGA.

21. Result of Match or Championship - Competition Closed

21a) Match Play

The result of a match is officially announced when it has been recorded in the Championship Office.

21b) Stroke Play

When the Championship trophy is presented to the winner, the results of the competition are officially announced, and the competition is closed.
